

# About the College



### **Taking the Legacy Forward**

Shyam Lal College (SLC) is a premier educational institution offering a vibrant inclusive environment for the development of excellence in curricular, co-curricular and extracurricular activities. Founded in 1964 by the great visionary and entrepreneur Padmashree (Late) Shri Shyam Lal Gupta, Shyam Lal College (SLC) is a co-educational constituent college of the University of Delhi. SLC is among the best institutions in the entire University of Delhi, and over the past several years, has been making steady progress towards achieving academic excellence. SLC is a dynamic centre of academic excellence and aspires to make



quality education accessible to the students, especially girls, from economically and educationally disadvantaged communities of East Delhi. The College campus has a sprawling sports ground and is full of lush green lawns and blooming gardens that create a natural ambience of a holistic teaching learning process. Over a period of 59 years, SLC has evolved as a leading higher education institute of learning, innovation and knowledge creation with consistent good NIRF ranking for Colleges of India. The College has also been selected for DBT STAR College Programme under the Ministry of Science and Technology in 2020. Recently, the College has been awarded an A++ rating by National Academic Accreditation Council (NAAC), Universities Grant Commission (UGC) in 2022. The College has rapidly emerged as a prominent educational institution of the Country and the Hon'ble Vice- President of India, Shri M. Venkaiah Naidu has graced the Annual Day function (2018-19).

The endeavor of the College has always been to make higher education more committed, job- oriented, meaningful and pragmatic, and at the same time more adaptable to the ever-changing demands of our society and globe. The College has taken several innovative initiatives towards creating a culture of innovation amongst students. SLC established Innovation Council (IC) under MoE's Innovation Cell, an initiative launched in November 2018. SLC's Innovation Council works towards inculcating the spirit of innovation among students, and develop a start-up ecosystem. The Skill Development Centre of the College offers many Value-added Courses and Certificate and Diploma Courses in German, Spanish, French, Chinese, Japanese, Korean (Affiliated to Department of Germanic and Romanic Studies, University of Delhi) as well as Certificate course in stock trading "Mastering the Stock Market" in collaboration with BSE Institute Ltd. The College also offers value-added courses on Yoga and Holistic Development, Research Analytics, Introduction to Artificial Intelligence and Introduction to Bitcoin and Blockchain Technology, Virtual Introduction and Digital Marketing. SLC is a participating institution in the Unnat Bharat Abhiyan (UBA 2.0) - a flagship programme of MoE, GoI. Under this project, SLC team of faculty and students have conducted surveys and workshops across 5 villages - Dhitora (Baghpat), Nithora (Ghaziabad), Chirodi (Ghaziabad), Jawli (Ghaziabad), Kotwalpur (Ghaziabad) to support rural development through institutional linkages. SLC has achieved another remarkable milestone with the Ministry of Education recognizing SLC as SAP (Swachhta Action Plan) institution in 2020.

At SLC, we encourage our students to become responsible citizens with critical thinking and analytical abilities, thereby contributing to the development of a healthy environment and a society free from any kind of discrimination and bias. Our objective is to nourish, nurture and promote holistic higher education, providing equal opportunity to all.

### Social Role

SLC makes all efforts to fulfill its institutional and social responsibilities towards all its stakeholders and the community. Through collaboration with community organizations, industry partners and civic groups, SLC constantly strives to find innovative solutions to societal issues. With the aim to correct gender inequality, the College offers 1% concession in marks at the time of admission to the girl students. The College is also committed to making a contribution in eliminating the prevailing inequality in NCR region through imparting wholesome higher education to all. In practice, the College has been correcting this imbalance at the grass-root level, with its geographical proximity to the most backward localities of Delhi. Time and again, through its various units like NCC, NSS, Gandhi Study Circle, Ambedkar Study Circle and Eco-Club, the College has initiated social welfare activities and created possibilities for equitable social development. The College also aims at promoting sports and indigenous games and has

been actively engaged in providing free and regular coaching to the deserving and talented underprivileged students coming from East Delhi as well as the nearby areas of U.P. A number of awareness programmes including sanitation, plantation drives, financial literacy programmes have been popularized in the nearby areas with the active participation of our students and faculty members and the College strives to continue with the same. With these initiatives, SLC has become a pioneer institution in Delhi. Students from far off states and regions, including the north-eastern states, as well as foreign students assimilate well in the corporate life of the Institution. In all, the College administration and faculty work towards providing an enabling environment to all the students.

### Connectivity

The College is well-connected by the Metro Rail network and road. The flyover from Welcome Metro Station to ISBT will connect SLC to North Campus, University of Delhi with a travelling time of 10 minutes. The Metro Stations of Welcome and Shahdara which fall on the



Rithala-Shaheed Sthal (New Bus Adda) Metro route via Kashmiri Gate are both at a walking distance from the College and provide the fastest and most convenient mode of transportation from most parts of the city and neighbouring towns of NCR. In addition, the College is well-connected by road and bus services to various parts of the city. The famous Grand Trunk Road (G.T. Road) runs just adjacent to the College and connects it to the neighbouring towns of U.P. such as Sahibabad and Ghaziabad as well. The Inter State Bus Terminal (ISBT) at Kashmere Gate and ISBT at Anand Vihar are less than 5 kms away from the College. The Anand Vihar railway station provides very good direct connectivity to the College for students coming from eastern parts of the country.

#### Infrastructure

SLC has modern and updated classrooms, tutorial rooms, multi-purpose hall, seminar/conference rooms well equipped for blended learning. The College is fully equipped with state-of-the-art Computer labs,

Science labs, Knowledge Resource Centre and Library, Sports facilities to upgrade knowledge, skills and capabilities of the students needed to groom them as future leaders. The college has added a new 2nd floor to its existing building which was inaugurated as the 'Centenary Block' by the Hon'ble Minister of Education Shri Dharmendra




Pradhan ji. This new addition has given immense boost to the infrastructure of the college with addition of 30 new classrooms, Multi-purpose Hall, 2 Innovation Plazas and 2 Computer Labs.



### Wi-Fi & CCTV Enabled Campus

The College makes continuous efforts to ensure that its infrastructure remains capable of meeting all the diverse needs of a healthy educational system in a dynamic environment. SLC takes pride in being a Wi-Fi and CCTV enabled modern campus. The College has completely renovated its old building with the installation of two lifts, six brand new washrooms and a new reception area that make it a fully differently-abled friendly area. The lush green gardens in and around the



campus have completely changed the landscape of the College. In the academic year 2015-16, the College added an entire new building - the Porta Block to its existing infrastructure. This building has state-of- theart infrastructure including CCTV surveillance system and a dedicated Conference Hall, Board Room, Teacher's Facilitation Centre with up-to-date ICT facilities. The Staff Room, Library, Office and Cafeteria have been recently renovated into fine air-conditioned spaces. The College has successfully implemented a fully functional CCTV surveillance system in and outside the campus. This ensures adequate safety and security to our students. The SLC campus is now a Wi-Fi zone with internet access available to each and every student and faculty member of the College. As a premier institution, SLC ensures that this infrastructure remains completely accessible to all its students and faculty, including the differently-abled.

### Library

In any knowledge-imparting institution, the library as the storehouse of knowledge plays a pivotal role. It not only provides an additional space to the students and teachers to interact with each other but also facilitates in connecting them to the world of books, journals and the information industry of the newly emerging world system. SLC has a fully equipped library with a huge collection of books, journals, magazines, e-resources. The library features WEB OPAC system and DELNET which makes it easier for students and faculty to find books in the library and elsewhere. DULS (Delhi University Library System) provides access to e-resources such as e-journals, eshodhSindhu, eshodhGanga etc. The college library also has NList membership (UGC- INFLIBNET) that allows users access to huge database of e-resources. Our library is fully automated, and RFID technology will be implemented in the near future. DULS and NList provide access to e-resources such as e-journals.

The Knowledge Resource Centre of the college provides students and teachers access to e-resources, world's best database, e-journals, e-books and reports. It has a seating capacity of 50 people. Each cubicle has its own computer system. Practical classes for students are also conducted here. It has constructed a state-of-the-art Reading Room with a large seating capacity. The library also has an important designated facility for the PwBD students of the College in the form of PwBD Facilitation Centre which has dedicated computer systems with all the relevant software installed so as to facilitate the smooth imparting of education to PwBD students.



#### **Science Laboratories**

SLC strives to provide the best of facilities to its students with various science laboratories. The Chemistry, Physics and Electronics labs with the best equipments and efficient support services offer ideal conditions to science students to carry out their practical work. The Biology lab was set up just a few years back in the college and is just being rapidly brought up to the level of its other science labs. These labs are not only spacious and well ventilated but also provide an ideal environment to students for academic excellence.



#### **Computer Centre**



The College has five computer laboratories and a dedicated Knowledge Resource Centre. SLC boasts of state-of-the-art computer centres equipped with servers, printers, desktops, laptops, LCD projectors and scanners of the latest configuration. Additionally, two new computer labs wellequipped with modern amenities are expected to be functional very soon. All the operations in the college library as well as the administrative office are automated. The Computer Labs of the College offer the best

in terms of hardware and software resources to the students and the faculty.

### Multi-Purpose Hall & Conference Centre

A state-of-the-art air-conditioned Conference Hall equipped with all the latest ICT facilities is part of the existing infrastructure. It has a seating capacity of 100 audience. The Conference Hall is fully functional and is utilized to conduct all the academic extension activities, conferences and seminars that are

organized in the college. A brand new Multipurpose hall (MPH) is also fully functional. Continuing with the academic excellence, various International and National Conferences were organized in the Conference Hall, Board Room, Knowledge Resource Centre and Reading Room.



### **Board Room and Teacher Facilitation Centre**

There is a newly constructed Teacher Facilitation Centre to promote research aptitude among the teachers and a Board/Committee room with a huge seating capacity.

### Cafetaria

The Food Court, the students' favourite hangout, is where the action is. With lots of yummy food at reasonable prices, this is a place where students from all streams meet, interact and confabulate over steaming cups of tea/coffee. Cold drinks, fruit Juices, crispy spring rolls, delicious idli, vada, dosa, patties, samosas, chhole bhature and bread pakodas are among the various food items on offer.



### **Medical Facility**

The College has a dedicated medical room. A physician visits the college thrice a week. The students may also avail the W.U.S. (World University Service) Health Centre facility in B.R Ambedkar College.

### **Girls Common Room**

SLC very much recognizes the need for exclusive private spaces for its students, in view of the fact that students have to spend several hours in the College, not all of it needs to be inside the classroom. This makes the Girls Common Room an important area of the College. Equipped with very good recreational facilities, the GCR has recently been refurnished. The GCR Committee of the college took the pioneer step to install a Sanitary Napkin Vending machine in the GCR in collaboration with CSR Research Foundation.

#### Security Arrangements

Located in the heart of East Delhi and with all major means of transportation available right in front, the College has the great advantage of being located at a completely safe and secure part of the city. The fact that the Shahdara Police Station is situated just adjacent to the College further enhances this sense of security. Further, the posting of police officers very close to the College premises imparts a sense of safety and security to the students travelling to and from the institution. Within the premises, the College tries to instill values of respect and mutual trust among all sections of the College in which everyone can work without fear and suspicion towards the achievement of their goals. Nevertheless, the College does not take security within the premises for granted, and keeps its infrastructure and human resources operating at all times to detect any security breaches.

# Flagship Programmes

### Unnat Bharat Abhiyan, SLC

SLC (University of Delhi), Shyam Lal College is a participating institute in the Unnat Bharat Abhiyan (UBA 2.0) which is the flagship programme of MoE, GoI. Under this project, SLC has adopted 5 villages - Dhitora (Baghpat), Nithora (Ghaziabad), Chirodi (Ghaziabad), Jawli (Ghaziabad), Kotwalpur (Ghaziabad) to support rural development through institutional linkages. The Unnat Bharat Abhiyan team comprises of faculty members and student members of SLC who have conducted extensive surveys of the said villages, participated in the Swachata hi Sewa campaign, interacted with villagers

### SAP (Swachhta Action Plan) Under MoE

SLC has achieved another remarkable milestone with Ministry of Education recognizing SLC as SAP (Swachhta Action Plan) institution in 2020. Under this scheme, SLC has undertaken to work towards essential swachhta activities including sanitation and hygiene, waste management, water management, energy management and greenery. To achieve the above tasks, the College has formed committees that are actively charting out plans to work in the defined areas for maximum benefit of the institution and its stakeholders.







### Adoption of Villages

SLC is a participating institute in the Unnat Bharat Abhiyan and has adopted 5 villages in Uttar Pradesh: Dhitora (Baghpat), Nithora (Ghaziabad), Chirodi (Ghaziabad), Jawli (Ghaziabad), Kotwalpur (Ghaziabad). Under this initiative, the UBA team has conducted extensive surveys of the said villages and interacted with villagers and other stakeholders of the villages such as village Pradhans and village panchayat samities and other stakeholders. The village visits, surveys conducted, data collected and interactions with villagers and concerned stakeholders of the villages have helped the team to



shortlist problem areas for further assistance. The SLC team planned and executed awareness campaigns for financial literacy including availing government financial incentives and schemes, insurance plans and health insurance, workshops for awareness around sanitation issues in the villages, campaigns about conservation of water, waste management, non-use of polythene, distribution of cloth bags and practical solution for proper waste management.





The College has also taken up the task of helping the ones in distress and to reach out to the villages during COVID-19 pandemic. As part of our social responsibility as an academic institution and on humanitarian grounds too, the College emerged as a flagbearer in spreading awareness about the probable reasons for the spread of COVID-19, its likely implications and what measures to be undertaken to reduce its consequences. A WhatsApp group with members from the villages like the Pradhans, village elders and officials has been formed to spread awareness about the do's and don'ts during this pandemic and the national lockdown. The student

members made handmade soap and distributed them in their neighbourhood so as to help people maintain good hygiene and fight this chronic disease. The College is actively involved in food distribution among the poor and the homeless. The college volunteers also distributed masks in the villages and the adjoining areas of college. Hundreds of masks were not only distributed free of cost but even the villagers were apprised of the ways to use and dispose off the same.

### Student Mentoring Programme

SLC has successfully implemented mentorship programme through IQAC of the College, for all the students. Under this full-fledged mentorship programme, all the students are assigned to designated faculty members during their stay in the college.

### Assessment and Feedback

The College has also successfully implemented the structured feedback system that ensures that the concerns of the students are heard and addressed. So far, we have successfully completed five cycles of taking holistic feedback from the students that have been analysed and the issues related to academics, infrastructure and facilities raised have been addressed. Along with this, the IQAC also takes feedback on curriculum from different stakeholders. The action taken report is subsequently prepared and discussed with the different departments.

### **Community Outreach Programme**

SLC is actively sensitive to its Institutional Social Responsibility and promotes institution-neighbourhood - community initiatives and outreach programs through its various activities that broadly fall under NCC/NSS/WDC/EOC/Sports. SLC is surrounded by many underdeveloped, overpopulated and minority community localities, and so becomes the sole facilitator, in the area, of achieving academic excellence for students belonging to economically backward classes and minority communities. The following are the community outreach steps that the college facilitates:

- The College has NCC, NSS, Women Development Cell, Centre for Holistic Development, Centre for Industry Interaction and Skill Development, Ambedkar Study Circle, Gandhi Study Circle etc. which organize events dedicated towards community service like blood donation camp, tree plantation drive, Save Yamuna Campaign, gender sensitization, identity discourses, moral education etc. to enhance the sense of community feeling and citizenship among the students.
- SLC has also adopted Shahdara mandi and regularly conducts cleanliness drives cleanliness drives, switch over to cashless trading and plastic free campaigns.
- SLC's policy of giving preference to the girl students in the Admissions is largely aimed at correcting the gender bias/disparity in the neighbourhood and community.
- The College promotes sports and games in the trans-Yamuna region of Delhi by providing opportunities and best coaching facilities to the young and talented players from low-income groups or underprivileged sections of society.
- The College has conducted various surveys in the past, including the survey as part of the project 'Old Age Homes in Delhi – Understanding the Challenges Faced by Them and Their Contribution to the Society'. The primary objective of this project is to have a closer view at the old age homes



functioning in Delhi in order to assess the problems and challenges that these institutions are facing.

- NSS volunteers of the College visit slum areas and spread awareness about cleanliness in collaboration with NGOs. The tree plantation activities organized by the College are aimed at improving the air quality in and around the College, as well as for creating awareness about protection of environment.
- WDC regularly organises activities to sensitize the students and staff to gender



related issues and to promote respect for human beings irrespective of race, religion, colour or gender.

- Most of the activities of the Equal Opportunities Cell such as remedial classes and Spoken English classes for students from under-privileged communities and facilities for differently abled also largely benefit the students from surrounding areas.
- The College participates in all national initiatives aimed at promoting good citizenship such as cleanliness drive, skill and entrepreneurship development initiatives, "Make in India" campaign, etc.
- The College has set up Centre for Skill Development following the launch of this programme by the Union Government.
- SLC has adopted 5 villages under UBA project under MoE, GOI.
- The NSS of the College also regularly organizes "Nirbheek" One week Women self-defense camp for girl students. The UBA team and NSS team of the College has already conducted cleanliness drives in Yamuna Bazaar Ghat no 21. The Development and Maintenance of Ghat No.-21 has been done along with repairing, beautification, restructuring, painting and colouring work.
- The NSS wing of the College lives up to its motto "Love All and Serve All". The students engaged with NSS volunteer with a number of NGOs. They also organize clothes donation drives to support NGOs like Amar Jyoti. The NSS, every year, organizes a blood donation camp in the College. NCC girls of SLC have participated and organized Self- defense Camp, Yoga Camp, Tree Plantation drive and save Yamuna Campaign'.
- The College also provides fee concession, financial aid, book aid, awards and prizes to students from underprivileged sections of society.



• The Enactus team of the College has worked on community outreach projects like "PRAYOJYA" (2018). The project is an effort to reduce plastic pollutants in our surrounding by transforming them

from waste plastic bottles to useful and decorative plastic utensils and simultaneously providing employment to women from underprivileged communities and train them in the art of making different kinds of decorative stuff with plastic.

 Various centres of SLC viz. Innovation, E-cell, CSD of the college collaborated with several research institutes and departments to explore the student's latent skills and also conducted field trips, industrial and educational visits. Women Development Centre (WDC) in collaboration with National Service Scheme (NSS) and Swachhta Action Plan (SAP) of SLC organised awareness program on "Menstrual Hygiene Awareness Campaign".

### **Counselling Services**

The Head of the institution regularly meets and interacts with students via virtual platform in order to resolve their queries regarding uncertainty of the academic session due to the pandemic situation. Counselling Services have been activated with Mobile no. of professional counsellor and doctor to address students' anxiety and other issues. The college also regularly organizes counselling sessions for students through ICC and WDC. The Principal follows the open door policy and is always available to students during office hours. The College has a very active mentoring mechanism in which teachers mentor and regularly meet their mentee (students) in order to resolve their academic and other concerns. During the Covid-19 pandemic, the college also facilitated the mobile data recharge of students' phones so that they do not miss out on interactions and classes with teachers.

such as Sajagta, Steam Power generator, Infollege, and Abhikalpana etc. Four SLC faculty members have successfully completed the Ambassador Training Programme conducted by Innovation Cell, MoE, GOI and it has received 3 stars since its establishment.

### Powered by Renewable Energy

The Solar Power plant of the College is fully functional and generates power covering 45% of our peak demand. The Solar Power plant, installed in the college, is a collaborative initiative with IPGCL, Govt. of NCT of Delhi wherein the said govt. agency has borne the full cost of the installation of the Solar panels in the college. We have been saving power as well as financial resources since the plant became fully functional. The College also practices regular switch off drives so as to save and conserve energy.



### Other Green Initiatives

Conservation of environment has been the focus of College. The students and faculty members of the College work in coordination to cultivate and preserve a green environment.

- The college is a tobacco-free, smoke-free zone and has said a loud 'NO' to crackers and plastic bags.
- The tree plantation activities organized by the College are aimed at improving the air quality in and around the College, as well as for creating awareness about protection of environment.
- The College takes special care to inculcate the habit of switching off fans and lights when these are not in use.
- All garden waste is used for making compost in compost pits.



- The college promotes energy saving initiatives and encourages all stakeholders to use battery power vehicle.
- Burning of garden waste is strictly prohibited on the Campus to minimize air pollution.
- E-waste is routed through appropriate channels for proper disposal.
- In order to ensure safe drinking water, the College has installed ROs in the campus.
- The college has developed pedestrian friendly pathways. All are encouraged to use the same
- College also engages in tree plantation in and around the campus.
- Renewable energy in the college is also an important focus area.
- College made efforts for carbon neutrality, with large green-patches, gardens, and a vast collection of trees.
- College has installed three LED screens to communicate with students and faculty to reduce the use of paper in printing official notices etc.

- The College is increasingly shifting to the use of LED lights.
- E-waste generated in the campus is managed as per the E-Waste Management through a committee. The E-waste is disposed off to authorized recyclers.
- The Garden Committee attempts to ensure the use of natural fertilizers and natural material for supporting plants and climbers.

### **Rain Water Harvesting**

As the institution is committed to zero water wastage and harnessing, the power of every drop of this precious commodity, SLC has taken important measure like rain water harvesting system.

### **Recycling Papers**

SLC is sensitive towards the cause of conserving natural resources and promotes the culture of respecting nature. SLC, in collaboration with NGO Jaagruti, has started recycling of waste papers and in return has received numerous reams of paper.

### **LED Lights**

The usage of LED lights has reduced the power consumption heavily. The installation of LED lights following the installation of solar panels has helped the College to save its financial resources. In addition to it, switch-off drills are carried on regular basis to make the SLCians aware and alert regarding energy consumption and saving.



### Sewage Treatment Plant

The college has sewage treatment plant of capacity 75000 L which is fully operational.

### **Opportunities for Under-Privileged Children in Vicinity**

SLC aims at promotion and improvement of sports and games in trans-Yamuna region of Delhi by providing opportunities and best coaching facilities to the young and talented players of the society. The endeavor is to provide a platform to young talented players with state-of-the-art amenities so that they learn, train and improve their standard in sports and games, and excel at the international and national level. For the purpose, the college has taking a new initiative



to provide free and regular coaching in the above mentioned games to deserving and talented students from neighboring schools. The aim is also to promote indigenous games among the youth who are in some ways unaware of the vast career possibilities to be explored in our national games and sports.

#### **Digital Practices**

The College has already adopted digital practices in all office and students related work. IQAC collaborates with various departments to organize virtual lectures and talks and interviews of imminent personalities across the world. The College also encourages the faculty to record lectures through screen cast-o-matic v2.0 software for future reference and benefit of the students.

The Administration took the digitalization one step further by transfiguring the students' I-cards into Single Sign-on (SSO) card. This card bearing bar-code is an in-house product developed by the technical team of the college. This one stop card is revolutionary as it makes the entire data just one click away and so is less time- consuming with minimum chances of being faulty and ensures better access to the on-campus facilities like:

- **Issuing books in library-** the students can issue books with the help of SSO card and they would not require any separate library card.
- **Security-** It makes screening easier on special days like student elections, College fest, annual function etc. to avoid any scuffles and untoward incidents in the campus.
- **Payment of bills-** the College is also thinking of creating a pay wallet which will be connected with students' account so as to make their campus experience better. The Administration is virtually in touch with the non-teaching staff all the time during office hours. All the officials of the College are connected with the Principal through Google worksheet where routine jobs are assigned to concerned officials and are routinely monitored.
- The College teaching staff is always updated with real-time LED display in the staffroom which is used for the display of time-table and other important notices.

#### Inclusive Education and Development

The practice of Inclusive Education and Development continues from the last year as it serves meaningful benefit for the students. Since the location of the College is very strategic, the students from NCR/North-East Delhi get the maximum benefit of studying in a premier Delhi University College. # Internal Quality Assurance Cell (IQAC)

As per National Assessment and Accreditation Council (NAAC) guidelines, every accredited institution should establish an Internal Quality Assurance Cell (IQAC) as a post-accreditation quality sustenance measure. Since quality enhancement is a continuous process, the IQAC works towards realization of the goals of quality enhancement and sustenance. 

# NEP 2020 & Undergraduate Curriculum Framework (UGCF)

New Education Policy (NEP) - 2020 has been framed to facilitate multiple entries and exit from a chosen course and leads to the holistic development of students so as to make them industry ready through implementation of Undergraduate Curriculum Framework-2022 (UGCF). Such an approach seeks to provide students with quality learning experience, where they observe, analyse and learn. The following objectives of NEP are kept in perspective while framing UGCF:

- 1. To promote each student's holistic development in both academic and non-academic spheres.
- 2. To provide flexibility to students so that learners have the ability to choose their learning trajectories and programmes, and thereby choose their paths in life according to their talents and interests.
- 3. To eliminate harmful hierarchies among disciplines/fields of study and silos between different areas of learning.
- 4. Multidisciplinary and holistic education to ensure the unity and integrity of all knowledge.
- 5. To promote creativity and critical thinking and to encourage logical decision-making and innovation.
- 6. To promote ethical, human and constitutional values.
- 7. To promote multilingualism and the power of language in learning and teaching.
- 8. To impart life skills such as communication, cooperation, teamwork, and resilience.
- 9. To promote outstanding research as a co-requisite for outstanding education and development.

#### Details of UGCF under New Education Policy

- 1. *Academic Credit:* It is a unit by which the course work is measured. It determines the number of hours of instructions required per week. One credit is equivalent to one hour of teaching (lecture or tutorial) or two hours of practical work/field work per week.
- 2. *Courses of Study:* It indicates pursuance of study in a particular discipline. Every discipline shall offer different categories of courses of study, viz. Discipline Specific Core courses (DSCs), Discipline Specific Electives (DSEs) and Generic Electives (GEs), Ability Enhancement Course (AEC), Skill Enhancement Course (SEC) and Value Addition Course (VAC).
  - *a) Discipline Specific Core (DSC):* It is a course of study, which should be pursued by a student as a mandatory requirement of his/her programme of study. DSCs shall be the core credit courses of that particular discipline which will be appropriately graded and arranged across the semesters of study, being undertaken by the student, with multiple exit options as per NEP 2020. The DSCs specified in the framework would be identified by the concerned department as core courses to be taught in a Programme. For example, for award of single discipline specific Honours degree, such as B.Com. (Honours), B.A. (Honours) English, B.Sc. (Honours) Physics and similar such programmes, DSCs shall be the core courses of Commerce, English and Physics respectively.

However, to pursue Honours degree programme in a 'Field of Multidisciplinary Courses of Study' (rather than a single discipline) such as B.Sc. (Honours) Life Sciences, B.A. (Honours) Social Sciences/Humanities, the DSCs shall comprise of core credit courses of more than one discipline.

For example, for B.Sc. (Honours) Life Sciences programme, a student shall study credit courses of three disciplines i.e., Botany, Zoology and Chemistry. DSC 1 may be of Discipline A1 (say, Botany), DSC 2 may be of Discipline B1 (say, Zoology) and DSC 3 may be of Discipline C1 (say, Chemistry). However, the fourth year of such honours degree programme shall be devoted to the study of only one discipline and hence the DSC courses in the VII and VIII semesters shall be of Discipline A/B/C and not a combination of these three disciplines.

Types of Courses	Description
Discipline Specific Compulsory (DSC) Course	A mandatory paper from the chosen course.
Discipline Specific Elective (DSE) Course	An elective paper from the chosen course.
Ability Enhancement Compulsory Course (AECC)	Knowledge enhancement through different areas of studies like Literature, environment, usually a compulsory paper offered to all the courses alike.
Skill Enhancement Course (SEC)	An elective paper for hands-on-training, proficiency and a certain set of KSAs (Knowledge, Skill and Abilities).
Generic Elective (GE)	An elective paper from the department other than the department where the admission is sought. For instance, a B.Com (Hons.) student may opt for a GE paper offered by the Department of Economics or English.
Value Added Course (VAC)	A new type of paper in NEP 2020 with an objective of personality development, communication and inculcating a knowledge about Indian culture, society.

#### **Types of Courses**

b) Discipline Specific Elective (DSE): It shall be a pool of credit courses of that particular discipline (single discipline programme of study) or those disciplines (multidisciplinary programme of study), as the case may be, which a student chooses to study from his/her particular discipline(s). There shall be a pool of DSEs from which a student may choose a course of study. The DSEs specified in the framework would be identified by the concerned Department as elective courses to be taught in a Programme. For example, to pursue B.Sc. (Honours) Physics, DSEs chosen should be from a pool of DSEs of Physics. Similarly, to pursue B.Sc. (Honours) Life Sciences programme, the DSEs chosen should be a pool of courses of DSEs of Botany, Zoology and Chemistry, the core subjects for this programme of study.

However, to pursue Honours degree programme in a 'Field of Multidisciplinary courses of Study' (rather than a single discipline) such as B.Sc. (Honours) Life Sciences, B.A. (Honours)

Social Sciences/Humanities, in the fourth year of such honours degree programme in the VII and VIII Types of Courses semesters, the student shall be required to choose DSEs from any one of the Disciplines A/B/C and not a combination of these three disciplines.

- c) Generic Elective (GE): It shall be a pool of courses which is meant to provide multidisciplinary or interdisciplinary education to students. GEs shall consist of a pool of courses offered by various disciplines of study (excluding the GEs offered by the parent discipline), in groups of odd and even semesters, from which a student can choose. The GEs specified in the framework would be identified by the concerned Department as GEs to be taught in a Programme. In case a student opts for DSEs beyond his/her discipline specific course(s) of study, such DSEs shall be treated as GEs for that student.
- *d)* Ability Enhancement course (AEC), Skill Enhancement Course (SEC) & Value Addition Course (VAC): These three courses shall be a pool of courses offered by all the Departments in groups of odd and even semesters from which students can choose. A student who desires to make Academic Project/Entrepreneurship as Minor has to pick the appropriate combination of courses of GE, SEC, VAC, & Internship/Apprenticeship/Project/Community (IAPC) which shall be offered in the form of various modules as specified in the scheme of studies.
  - (i) AEC courses are the courses based upon the content that leads to knowledge enhancement through various areas of study. They are Language and Literature and Environmental Science and Sustainable Development which will be mandatory for all disciplines.
  - (ii) SEC are skill-based courses in all disciplines and are aimed at providing hands-on training, competencies, proficiency and skills to students. SEC courses may be chosen from a pool of courses designed to provide skill-based instruction. Every discipline may provide skill-based courses, some of which may be offered to students of its discipline while the rest can be open to students of all other disciplines.
  - (iii) VAC courses are common pool of courses offered by different disciplines and aimed towards personality building; embedding ethical, cultural and constitutional values; promote critical thinking, Indian Knowledge Systems, scientific temperament, communication skills, creative writing, presentation skills, sports & physical education and team work which will help in all round development of students.

#### 3. Major Discipline

- a) A student pursuing four-year undergraduate programme in a specific discipline (Core course) shall be awarded an appropriate Honours degree with Major in a Discipline on completion of VIII Semester, if a student secures in that Discipline at least 50% of the total credits i.e., at least 88 credits in that Discipline out of the total of 176 credits. Student shall study 20 DSCs and at least 2 DSEs in eight semesters. For instance, a student who pursues B.Com. (Honours) shall earn the minimum 88 credits from 20 DSCs and at least two DSEs in order to get Major in Commerce.
- b) A student pursuing four-year undergraduate programme in more than one discipline as Core Course (for example B.A. Social Sciences/Humanities, B.Sc. Life Sciences, B.Sc. Physical Sciences, B.Sc. Mathematical Sciences, B.Com. and such other programmes) shall be awarded appropriate Honours degree with Major in a Discipline on completion of VIII Semester, if a student secures in that Discipline 80 credits out of a total of 176 credits. Student shall

study 6 DSCs and at least 3 DSEs in that discipline in the first six semesters and 2 DSCs, 6 DSEs and write dissertation in that discipline in the VII and VIII semesters. For instance, a student who pursues four-year B.A. (Honours) Social Sciences/Humanities shall be eligible for Major in History, on completion of VIII semester, if a student earns minimum 80 credits from 8 DSCs and at least 9 DSEs of History and writes dissertation on a topic related to History.

#### 4. Minor Discipline

A student mentioned at 3(a) above may be awarded Minor in a discipline, on completion of VIII Semester, if a student earns a minimum 28 credits from seven GE courses of that discipline. For example, if a student pursuing B.A. (Honours) History chooses seven GE courses of Political Science out of a total of ten GE courses and writes dissertation, students shall be awarded on successful completion of VIII Semester, Major in History and Minor in Political Science.

A student mentioned at 3(b) above may be awarded Minor in a discipline, on completion of VIII Semester, if a student earns minimum 28 credits from six DSCs and one DSE of that discipline. For example, a student pursuing four-year B.A. (Honours) Social Sciences/Humanities with Major in History (after securing at least 80 credits in History), may be awarded Minor in Hindi if a student earns 28 credits from six DSCs and one DSE of Hindi (up to VI semester), on successful completion of VIII Semester. This definition of Minor is independent of GEs for which there is a requirement of 28 credits to be treated as Minor. Further, in case a student opts for two disciplines such as Physics and Chemistry instead of three disciplines such as Physics, Chemistry and Mathematics, major and minor shall be determined as per credits earned in the respective courses of study. The concept of Minor is relevant only when there is a Major discipline.



\*In case there is no end term practical examination for 4 credit course, which has only practical component, this mark shall be added to Continuous Assessment of the Practical and the total of the CA for Practical shall be 120.

#### **IA: Internal Assessment**

- Practical marks for courses of total four credits, shall comprise of
  - (i) Continuous evaluation (25%)
  - (ii) End-term practical examination (50%)
  - (iii) viva-voce (25%)
- Practical marks for courses of total two credits shall comprise of
  - (i) Continuous Evaluation (50%)
  - (ii) End-Term practical/written exam (25%)
  - (iii) viva-voce (25%)



- The variance of the total marks in various combinations of Lecture Theory Practical (LTP) structure shall be aligned with the help of "weighted average" calculated through an appropriately devised formula for conversion of marks to grades.
- Internal assessment shall consist of marks secured in class tests, assignments/presentations and attendance. For instance, for an Internal assessment of 25 marks, Class tests shall comprise of 10 marks, Assignments/Presentations/Project/Activity done as component of the Tutorial shall comprise of 10 marks and attendance shall be 5 marks.
- For continuous mode of assessment, minimum attendance required is 66%.
- If a student fails in continuous mode of assessment, the student shall be required to take readmission in the course to clear the paper/course.
- Under UGCF, the students are assessed following a system of grades, calculated on the basis of Cumulative Grade Points Average (CGPA). Such CGPA is taken as a consolidated score of all the semesters on a scale of 0 to 10, classification of which is presented below:

### Undergraduate Curriculum Framework (UGCF – 2022)

The UGCF - 2022 underlines the historical perspective, philosophical basis, and contemporary realities of higher education as enshrined in the National Education Policy (NEP – 2020) and endeavors to synchronize these cornerstones while charting the road ahead for the state of higher education.

The University of Delhi, a premier seat of teaching, learning, and research in higher education, acclaimed nationally and internationally, has nurtured the quest for reaching the peak in every sphere of education. In its true sense, it has contributed to nation-building. Moreover, being a central university, it is mandated to act as the torch bearer in expanding the horizons of human resource development through the expansion of higher education. A reflection of such sustained and continued endeavour is amply exemplified in the successive revision of the undergraduate curricular framework over the decades. Keeping pace with the emerging trends in higher education in the new millennium globally and with the critical importance of enriching the youth of our nation, the University always paces with the prevailing priorities of skill development through innovative and practically oriented teaching-learning modes.

To actualize the noble objective, as succinctly brought out in the NEP - 2020, the University of Delhi has endeavored to explore the possibility of further restructuring and refinement of its undergraduate curriculum framework. All such efforts will be in line with the objective and underlying philosophy of the NEP – 2020 which is to capture the imagination of the youth of our nation and depict the contemporary realities of our demographic advantage globally.

The resultant outcome of this comprehensive exercise undertaken by the University of Delhi is the UGCF - 2022 which not only underlines the hearth and soul of the NEP - 2020 in letter and spirit but also goes on to create a teaching-learning framework at the undergraduate level to attract the young minds towards research, innovation, apprenticeship, social outreach, entrepreneurship and similar such areas of human knowledge and endeavour while imbibing the truly charged academic environment of the University of Delhi and its constituent Colleges.

### Admission Requirements

- 1. Admissions to all Undergraduate Programs at the University of Delhi will be based on the scores obtained in CUET (UG) 2023, except for admissions to the School of Open Learning (SOL), Non-Collegiate Women Education Board (NCWEB) and Foreign Nationals.
- 2. An eligible candidate desirous of seeking admission to the Undergraduate Programs(s) of the University of Delhi for the academic session 2023-24 must read the contents of this Bulletin of Information, as well as the notifications, updates and information published on the admission website of the University of Delhi very carefully.
- 3. The candidate must have studied and passed Class XII Examination or its equivalent from a single recognized board.
- 4. The candidate must have passed Class XII examination of any Board / University examination in India, or any foreign country recognized as equivalent to the 10+2 system by the Association of Indian Universities (AIU).
- 5. For admission to University of Delhi, it is mandatory for the candidate to appear in CUET (UG) 2023 in those subjects in which s(he) is appearing/has passed Class XII.
- 6. In case the subject studied at Class XII is not mentioned in the CUET (UG) 2023, the candidate must appear in the Language/Domain Specific subject that is similar/closely related to the subject s(he) has studied at Class XII (for example, if a candidate has studied Biochemistry in Class XII, s(he) must appear in Biology in CUET (UG) 2023.
- Admission will be based only on the combination of scores of Language and/or Domain Specific subjects in which a candidate has appeared in CUET (UG) – 2023 as per the respective Program-Specific Eligibility.
- 8. Only the scores obtained in CUET (UG) 2023 will be considered for admissions to the academic year 2023-24.
- 9. Candidates must study the Program-Specific requirements carefully and then appear in Language and/or Domain Specific subjects of the CUET (UG) 2023.
- 10. The candidate is advised to check that s(he) satisfies all eligibility criteria for the program(s) for which s(he) is appearing in the entrance test. Admission is subject to the candidate's fulfilling the eligibility requirements prescribed for applying to the concerned program of study. In case a candidate does not meet any eligibility criteria prescribed for applying to the concerned program and appears in the entrance test, it is at the candidate's own risk and cost. If at any stage, it is found that eligibility requirements are not fulfilled, the admission if granted, shall be cancelled ipso facto.
- 11. Before registering for CUET (UG) 2023, the candidate is advised to carefully read the Bulletin of Information and consult the University of Delhi Act, 1922 and the Statutes. The Ordinances, Rules,

and Regulations of the University of Delhi, available on the University website, would be binding on him/her.

- 12. Candidates must be careful while filling the CUET (UG)-2023 form as certain fields such as Name, signature, and photograph of the candidate will be later auto-integrated by University of Delhi from CUET(UG) 2023. These fields will be non-editable.
- 13. As per Ordinance-I of University of Delhi, there is no minimum age bar for admission to the undergraduate programs in the University and its colleges except in the programs where the respective regulatory bodies, such as Medical Council of India (MCI), All India Council for Technical Education (AICTE), Bar Council of India (BCI), National Council for Teacher Education (NCTE), Dental Council of India (DCI), etc. have prescribed the minimum age requirement in their regulations.
- 14. Gap year will not be a bar for the purpose of admission to undergraduate programs. However, such candidates must also appear in CUET (UG) 2023 for admissions in the academic year 2023-24.
- 15. The name of the Candidate claiming reservation must match with the Candidate's name as it appears on their corresponding School Board qualifying certificates and in CUET (UG) 2023. Similarly, the parents' names must also match the certificates.

### Seat Allocation and Admission

### STEP 1 - Acceptance of the Provisionally Allocated Seat

- It is the responsibility of the candidate to login to the dashboard and check if a seat is allocated in a given round of seat allocation, and if allocated, the candidate must complete all admission formalities.
- Once a seat has been allocated in a particular round, the candidate must 'Accept' the Allocated Seat before the last date/time specified for the given allocation round. The provision for acceptance of a particular Allocated Seat will be valid only for the round in which the seat was allocated to the candidate.
- In case a candidate is offered multiple seats in a particular round, student must "Accept" ONE Allocated seat ONLY. Inactivity/no-action will be taken as non-acceptance to the Allocated Seat. It will be treated as a decline to the provisionally Allocated Seat and the candidate will no longer be able to participate in subsequent rounds of CSAS-2023.

### STEP 2(A) - Online Approval by the College

Once the candidate "Accept" the provisionally Allocated Seat, the concerned College will check the eligibility and documents uploaded by the candidate. The College will verify the following within the stipulated timeline:

- 1. Minimum Eligibility of the Candidate.
- 2. Program-Specific Eligibility of the Candidate.
- 3. Subject Mapping: University will consider only those CUET subjects in which candidate has passed Class XII.
- 4. Validity and authenticity of Documents/Certificates submitted by the Candidate.

During the online approval process, if a college seeks more clarity/information from the candidate, it may raise a query to the Candidate (refer to step 2b).

After verification, the College will either 'Approve' or 'Reject' the provisionally Allocated Seat of the candidate.

No application will be left unattended by the Colleges.

### In Case of Approval:

Once the College accords the approval, the candidate will have to pay the 'Admission Fee'.

### In Case of Rejection:

At the time of online verification, if an application gets rejected, the College will state the reason for rejection.

For rejecting an application, the College will indicate any of the following reason/s:

- 1. Non-fulfillment of the Minimum Eligibility by the Candidate.
- 2. Not-fulfillment of Program-Specific Eligibility by the Candidate.
- 3. Non-fulfillment of the subject-mapping criteria.
- 4. Invalid documents/certificates submitted by the candidate.
- 5. Failure to respond to the query(ies) raised by the College within the stipulated time.

### STEP 2(B) - Respond to Queries (if any) during College Approvals

During the online approval process, if a College raises a query(ies) then the candidate must respond online (through the candidate's dashboard) within the stipulated time. Failure to respond to the query(ies) will lead to rejection of the Allocated Seat and the candidate will be out of CSAS - 2023.

### STEP 3 - Admission to the Provisionally Allocated Seat

After the College approves, the candidate will have to pay the Admission Fee for the approved seat. The admission process will be treated as complete only after successful payment of the admission fee. If a candidate fails to pay the admission fee within the stipulated time, it will be considered as a cancellation of the provisionally Allocated Seat. The Allocated Seat shall be forfeited and the candidate will not be considered for any subsequent CSAS-2023 allocation rounds. The candidate will forfeit all the rights of the allocated seat and will not be considered for any subsequent CSAS-2023 allocation rounds.

### Subsequent Rounds of Allocation

### Option 1 - Upgrade

All candidates who have applied for CSAS-2023 will be eligible for all allocation rounds, except those whose allocated seat/admission has been cancelled for whatever reason. All admitted candidates who opt for the "Upgrade" option in a particular round will be considered for respective CSAS-2023 allocation round, subject to the availability of seats.

Candidates who were allocated their first preference in any round will not be considered in subsequent rounds of allocation.

Before the announcement of a round, the University will open an "Upgrade" Window for all admitted candidates.

An admitted candidate can select the 'Upgrade' option, which will allow upgradation to a higher preference submitted by the candidate. Admitted candidates who opt for upgradation will automatically be upgraded based on the allocation policy.

Choosing the option 'Upgrade' will mean that the candidate consents to consideration of an offer of admission to a Program + College Combination of his/her higher preference in the subsequent round (if any).His/Her current admitted seat will be auto cancelled if new preference/sis/are allocated.

A candidate who opts for 'Upgrade' can also reorder the Program + College Combinations that were higher in preference than the allocated one.

The Program + College Combination in which a student had taken an admission earlier will never be offered to the candidate in any subsequent round. Similarly, the Program + College combinations which were below in the preference order at which the candidate had taken an admission earlier will never be offered again to the candidate in any subsequent round.

The upgrade option will not be available for the candidate who was allocated her first preference.

It will be the responsibility of the candidate to keep checking for 'Upgrade' options in all rounds of seat allocations. Failure/inability to participate in the upgradation process will not be considered a grievance in any circumstance.

A candidate who gets upgraded will have to 'Accept' the upgraded seat and complete the admission procedures on the upgraded Allocated Seat/s. If a candidate does not do any activity on the upgraded seat/s, it will, by default, be considered cancelled and the candidate will be out of CSAS-2023.

In case, a candidate does not get upgraded, her admission to the earlier seat will be retained.

### **Option 2 - Freeze**

A candidate who has taken admission on an Allocated Seat and desires to continue with it should submit a 'Freeze' request through her dashboard. On selecting 'Freeze', such a candidate will never be allowed to opt for "Upgradation."

If an admitted candidate neither opts for upgradation nor opts for Freeze, and remains inactive for a round, the admission taken by student will be retained and will not be considered for upgradation.

### Cancellation of Provisionally Allocated Seat/Admission

- 1. Failure to 'Accept' the provisionally Allocated Seat within the stipulated timeline will lead to the cancellation of the Allocated Seat.
- 2. The provisionally Allocated Seat will be cancelled if a candidate fails to pay the Admission fees within the stipulated time.
- 3. The provisionally Allocated Seat/Admission will be cancelled if, at any time, any of the document(s)/certificate(s) is/are found to be invalid/fraudulent.
- 4. The provisionally Allocated Seat/Admission will be cancelled if, at any time, it is found that a candidate does not meet the Minimum Eligibility Criteria as declared by University.

A candidate whose provisionally allocated seat/admission is cancelled due to the above-mentioned reasons will forfeit the right to seek admission to University through CSAS-2023.

### $With draw al \, of Admission$

A candidate who has taken an admission but wishes to withdraw can do so through her dashboard by selecting the 'Withdraw' option and paying a withdrawal fee of Rs. 1000.00 (non-refundable).

A candidate who withdraws her admission will be out of CSAS-2022. Candidate will forfeit his/her eligibility for admission to UG Programs of University. No further participation in any of the subsequent allocation rounds (if any) will be allowed.

There will be no option to withdraw the admission once the Spot Admission round is announced.

### Mid-Entry

Candidates who failed to apply for CSAS-2023 within the stipulated time and are desirous of participating in CSAS-2023 can participate through the Mid-Entry window (whenever University announces it), by paying a Mid-Entry fee of Rs. 1000.00 (non-refundable).

A candidate who makes a Mid-Entry may be considered for allocation only after all the candidates who had applied earlier and have the merit score/s higher than the lowest declared score have been allocated.

It will be mandatory for the Mid-Entrant to take admission on the seat allocated to her, if offered. Failure to accept the allocated seat will forfeit the candidate's admission to University. There will be no option of 'Upgrade'.

Mid-Entry will not be allowed for ECA & Sports Supernumerary Quota.

### Spot Admissions

After the completion of regular CSAS-2023 rounds, if seats remain vacant, University may announce Spot round/s of admission.

Candidates who applied for CSAS-2023 but were not admitted to any College on the date of declaration of the Spot Admission round can participate in Spot Admissions.

On the announcement of Spot Admission, the admission of all already candidates will be locked and they will not be considered for upgrades. Similarly, the admitted candidates will not be allowed to withdraw their admissions.

To be considered in a Spot Admission round, the candidate will have to opt for 'Spot Admission' through her dashboard.

For every Spot Admission round the University will display the vacant seats of each Program. A desirous candidate will be able to select ONLY ONE Program.

It will be mandatory for the candidate to take admission to the seat allocated in a Spot round. Failure to accept the allocated seat in the Spot Admission round will forfeit the candidate's eligibility for admission to University and will be out of CSAS.

There will be no option of 'Upgrade' and 'Withdraw' during the Spot Admission rounds. The seat allocated in a particular Spot Admission round will be final and will not be upgraded in any subsequent round of Spot Admission rounds.

### Mandatory requirement of Physical Verification of Original Documents

At the conclusion of CSAS-2023, all admitted candidates would have to report to the admitted College and complete all the admission formalities of the concerned College, including physical verification of the documents/certificates.

Admission of a candidate is purely provisional and is subject to verification of original documents by the respective College. The College will recheck all the documents/certificates. During physical verification, if any document/certificate is found inadequate/ insufficient/ inappropriate, it will lead to cancellation of

the admission, ipso facto. Further, such a candidate will forfeit the opportunity for admission to any UG Program of University for the Academic Session 2023-24.

### Admission Grievance Redressal

### Level 1 - College Grievance Redressal Committee

Every College will establish a Grievance Redressal Committee to redress grievances that may arise during admission. In addition, a Sub-Committee of Grievance Redressal for redressing the grievances of candidates belonging to SC/ST/OBC/EWS/Minority and PwBD categories will also be established. The details of the College Grievance Redressal Committee and the Sub-Committee will be displayed on the website of the College and on the admission website of University to facilitate and address the needs/queries of candidates within the stipulated time. Candidates having grievances about admission should first approach the Grievance Redressal Committee of the concerned College.

### $Level 2\mbox{-} Central Grievance\, Redressal\, Committee$

If grievance/s is/are not resolved within a reasonable time by the College, then candidates may approach the Central Grievance Redressal Committee of University. This Committee will resolve allocation and admission-related issues of candidates. The details of the Central Grievance Redressal Committee will be displayed on the admission website of the University.

If a grievance is found relevant and genuine, and if seats in a specific Program + College combination have been filled, then such a candidate will be offered a supernumerary seat. The decision(s) by the concerned authorities with regard to grievances shall be final and binding.

Admission grievances related to NCWEB, ECA, Sports supernumerary quota, and CW will be redressed by the respective committees of University.

# Reservation Policies

### Reservation of Seats for Scheduled Caste (SC) and Scheduled Tribe (ST) Candidates

22.5% of the total numbers of seats is reserved for Candidates belonging to Scheduled Caste and Scheduled Tribes (15% for Scheduled Caste and 7.5% for Scheduled Tribes, interchangeable if necessary). The Candidate must be in possession of the Caste/Tribe certificate in his/her own name at the time of Registration and Admission.

The Caste certificate should clearly state:

- 1. Name of his/her caste/tribe
- 2. Whether the candidate belongs to SC or ST
- 3. District and the State or Union Territory of the Candidate's usual place of residence, and
- 4. The appropriate Govt. of India Schedule under which his/her caste/tribe is approved as SC or ST.

# The candidate will have to produce the valid original SC or ST caste/tribe certificate at the time of admission.

The following are empowered to issue the requisite SC/ST certificate:

- I. District Magistrate/Additional District Magistrate/Collector/Deputy Commissioner/Addl. Deputy Commissioner/Deputy Collector/1st class Stipendiary Magistrate/City Magistrate/Sub-Divisional Magistrate/Taluka Magistrate/Executive Magistrate/Extra Assistant Commissioner.
- II. Chief Presidency Magistrate / Addl. Chief Presidency Magistrate / Presidency Magistrate.
- III. Revenue Officer not below the rank of Tehsildar.
- IV. Sub-Divisional Officer of the area where the Candidate and/or his family normally resides.
- V. Administrator/Secretary to the Administrator/Development Officer (Lakshadweep Islands).

Candidates are to note that the SC / ST Certificate from any other person/authority shall not be accepted in any case. If the Candidate happens to belong to SC or ST, Candidate's caste/tribe must be listed in the appropriate Govt. of India Schedule. It is a statutory obligation on the part of colleges to fill all seats reserved for Scheduled Caste/Scheduled Tribe Candidates.

Colleges shall not refuse admission to any SC/ST Candidate on the basis of the medium of instruction. Any deficiency in the knowledge of any particular language should be addressed; for this purpose, remedial classes may be arranged by the College by utilizing grants available from University Grants Commission.

27% seats are reserved for the Candidates belonging to Other Backward Classes (OBC - Non-Creamy Layer, Central List).

At the time of giving admission to an OBC Candidate, the College will ensure that the caste is included in the Central List of OBC (the OBC status is to be determined on the basis of the Central (Govt. of India) List of OBCs notified by the Ministry of Social Justice and Empowerment on the recommendations of the National Commission for Backward Classes (available at the website http://ncbc.nic.in/backward classes/index.html.).

The certificate must mention non-creamy layer status of the Candidate (Non-creamy layer status issued by an authority mentioned in DOPT Office Memorandum no. 36012/22/93- Estt. (SCT) dated 15.11.1993).

The OBC Candidates who belong to the 'Non-Creamy Layer' and whose caste appears in the Central List of the OBCs only, shall be eligible to be considered for admission under the OBC category (Validity period of OBC certificate in respect of the 'non-creamy layer' status of the Candidates as per DOPT Office Memorandum No. 36036/2/2013-Estt. (Res-I) dated 31 March 2016). The certificate should be issued on or after 31st March, 2023.

It is a statutory obligation on the part of Colleges to fill the seats reserved for OBC Candidates.

### Reservation policy for Economically Weaker Sections (EWS)

As per the University of Delhi notifications (Reference No. Aca. I/Reservation of EWSs/2019/63 Dated 28th March 2019 and Reference No. Aca. I/Reservation of EWSs / 2019/101 Dated 15th May 2019), for the reservation for Economically Weaker Sections (EWSs) Category, the University Departments/Centres/Colleges have reserved 10% seats for admission of candidates belonging to EWS category.

### Extra-Curricular Activities (ECA) and Sports Quota

Candidates desirous of taking admission under the supernumerary quota for ECA and/or Sports must appear in CUET (UG) - 2023.

For admissions to ECA and Sports supernumerary seats a weightage of 25% will be given to CUET score and 75% to certificates/trials/performances.

### Admission to Supernumerary Seats

Admission to all supernumerary seats will be through CUET (UG) - 2023. Candidates desirous of taking admission to supernumerary seats must appear in CUET (UG) - 2023.

# Student Related Important Information

### Identity Card

Every student is issued an Identity Card by the college immediately after admission. Student is expected to carry his/her identity card with him/her at all times. Student will have to produce the same whenever required to do so by any member of the College staff in the college premises or outside or when he/she visits the college office for payment of fees or for any other purpose or when he/she goes to the College Library. If the identity card is lost, a fee of Rs. 50/- will be charged for issuing a duplicate card.

### Attendance Regulations

Every student must complete at least two-thirds attendance of the total lectures/practicals held during the academic year to be eligible to appear in the University Examination failing which the students would not be allowed to appear in the examination. Students are governed by the rules and regulations laid down by the University in its Ordinance VII.

Parents/guardians are expected to know the status of attendance of their ward at the end of each semester. The students falling short of attendance at the end of each semester are notified by the College Students Attendance Committee.

### **University Examination**

University of Delhi holds Examination/s for different courses for the final assessment of the students at the end of each semester. For details, students should regularly check the college notice board as well as college/University website.

Note: No student shall be deemed to have qualified for appearing in the University examination unless the student fulfills the required attendance rules and other conditions.

### **Migration**

- 1. As per University Rules, no migration is allowed in the first year.
- 2. Migration to the II year III Year from other Universities and Colleges may be allowed as per University Guidelines, subject to availability of seats and minimum percentage of marks as decided by the College.

### Discipline of the College

- 1. Students are expected to maintain a high standard of discipline and shall endeavor to promote the reputation of the Brand SLC and to inculcate camaraderie, mutual respect and healthy fellow feelings.
- 2. Student against whom disciplinary action has been taken may not be granted re-admission. Such a student, apart from disciplinary action against him/her, will be liable to forfeit any prizes won or position held, if so, decided by the College Proctorial Board. The College has a very active Proctorial Board and presently Mr. Sanjeev Kumar, Department of Economics is the convenor of the Board. Students may contact the Proctorial Board for any kind of information, assistance, and emergency. The college has also deployed a very active security agency and in case of any assistance or emergency, students may contact the security supervisor at his office near the college gate (All emergency/helpline numbers are displayed at the college gate).

### **Code of Conduct for Students**

- 1. The student shall refrain from;
  - Misbehaviour towards members of the staff (teaching and administrative) and fellow students;
  - Smoking, drinking, gambling and drug-taking in any form;
  - Eve-teasing;
  - Obstructing passage in the verandah;
  - Causing damage to college building, furniture, fixtures, garden, canteen crockery, or to any other property;
  - Making noise in or outside the classrooms;
  - Associating with outsiders to create indiscipline in any form in the college. No outsider will be allowed in the college without any expressed purpose and all visitors will have to make an entry in the visitors register;
  - Unauthorized entry into the college building on holidays; and
  - Unauthorized vehicle parking inside the College premises.
- 2. Students are liable to summary punishment for any of the offenses listed at clause (a) to (i) above or any other behavior considered as misconduct by the Proctorial Board.
- 3. Students are expected to be regular in their classes.
- 4. Students must keep the College neat and clean.
- 5. Students must observe complete silence in the Library and obey standing orders. They are expected to utilize the facilities properly.
- 6. Students may participate in their favorite games or sports, abiding by rules and regulations framed by the Sports Committee.
- 7. Students must always keep their Identity cards with them, and produce it as and when asked for.
- 8. Students are advised to see the General Notice Board, the Sports Notice Board, and the Library Notice Board as well as College website daily for obtaining up-to-date information of College notices/activities/programs.
- 9. West Bengal Prevention of Defacement of Property Act has been promulgated in Delhi to keep the city clean. Punishment for contravention of its provisions is an imprisonment for a term of six months or a fine of Rs. 1000/- or both.
- 10. Students are expected not to invite any guests during teaching hours in the College.
- 11. Suggestions from students are always welcome and will be given due attention.
  - The students are required to fill up the undertaking to maintain the Code of Conduct as notified by the University of Delhi failing which they might be subjected to disciplinary action.
  - The Students are required to submit an online undertaking as regards the prohibition of ragging by visiting the College website.
  - The students are required to observe all COVID-19 SOP while visiting the college for any work.

# Important Ordinances of the University

Successful Candidates will be required to abide by the Ordinances of the University and will be required to provide a written undertaking to this effect at the time of admission. A few extracts of important ordinances are reproduced here.

### **ORDINANCE XV-B: Maintenance of Discipline among Students of the University**

- 1. All powers relating to discipline and disciplinary action are vested in the Vice-Chancellor.
- 2. The Vice-Chancellor may delegate all or such powers as he deems proper to the Proctor and to such other persons as he may specify on this behalf.
- 3. Without prejudice to the generality of power to enforce discipline under the Ordinance the following shall amount to acts of gross indiscipline:
  - a. Physical assault, or threat to use physical force, against any member of the teaching and nonteaching staff of any Institution / Department and against any student within the University of Delhi.
  - b. Carrying of, use of or threat to use of any weapons
  - c. Any violation of the provisions of the Civil Rights Protection Act, 1976
  - d. Violation of the status, dignity and honour of students belonging to the scheduled castes and tribes
  - e. Any practice-whether verbal or otherwise-derogatory of women
  - f. Any attempt at bribing or corruption in any manner
  - g. Willful destruction of institutional property
  - h. Creating ill-will or intolerance on religious or communal grounds
  - i. Causing disruption in any manner of the academic functioning of the University system;
  - j. Prohibition of Ragging as per Ordinance XV-C.
- 4. Without prejudice to the generality of his/her powers relating to the maintenance of discipline and taking such action in the interest of maintaining discipline as may seem to him/her appropriate, the Vice-Chancellor, may in the exercise of his/her powers aforesaid order or direct that any student or students:
  - (a) be expelled; or
  - (b) be for a stated period rusticated; or
  - (c) be not for a stated period, admitted to a programme or programmes of study in a College, Department or Institution of the University; or
  - (d) be fined with a sum of rupees that may be specified; or

- (e) be debarred from taking a University or College or Departmental Examination or Examinations for one or more years; or that the result of the student or students concerned in the Examination or Examinations in which he/she or they have appeared be canceled.
- 5. Institutions, Halls and teaching in the concerned Departments. They may exercise their authority through, or delegate authority to such of the teachers in their Colleges, Institutions or Departments as they may specify for these purposes.
- 6. Without prejudice to the powers of the Vice-Chancellor and the Proctor as aforesaid, detailed rules of discipline and proper conduct shall be framed. These rules may be supplemented, where necessary, by the Principals of Colleges, Heads of Halls, Deans of Faculties and Heads of Teaching Departments in this University. Each student shall be expected to provide himself/herself with a copy of these rules. At the time of admission, every student shall be required to sign a declaration that on admission he/she submits himself/herself to the disciplinary jurisdiction of the Vice-Chancellor and several authorities of the University who may be vested with the authority to exercise discipline under the Acts, the Statutes, the Ordinances and the rules that have been framed therein by the University.

### **ORDINANCE XV-C:** Prohibition & Punishment for Ragging

- 1. Ragging in any form is strictly prohibited, within the premises of College/Department or Institution and any part of University of Delhi system as well as on public transport.
- 2. Any individual or collective act or practice of ragging constitutes gross indiscipline and shall be dealt with under this Ordinance.
- 3. Ragging for the purposes of this ordinance, ordinarily means any act, conduct or practice by which dominant power or status of senior students is brought to bear on students freshly enrolled or students who are in any way considered junior or inferior by other students; and includes individual or collective acts or practices which:
  - a. Involve physical assault or threat to use of physical force.
  - b. Violate the status, dignity and honour of women students.
  - c. Violate the status, dignity and honour of students belonging to the scheduled caste and tribe.
  - d. Expose students to ridicule and contempt and affect their self-esteem.
  - e. Entail verbal abuse and aggression, indecent gestures and obscene behavior.
- 4. The Principal of a College, the Head of the Department or an Institution, the authorities of college, or University Hostel or Halls of Residence shall take immediate action on any information of the occurrence of ragging.
- 5. Notwithstanding anything in clause above, the Proctor may also suo moto enquire into any incident of ragging and make a report to the Vice-Chancellor of the identity of those who have engaged in ragging and the nature of the incident.
- 6. The Proctor may also submit an initial report establishing the identity of the perpetrators of ragging and the nature of the ragging incident.

- 7. If the Principal of a College or Head of the Department or Institution or the Proctor is satisfied that for some reason, to be recorded in writing, it is not reasonably practical to hold such an enquiry, he/she may so advise the Vice-Chancellor accordingly.
- 8. When the Vice-Chancellor is satisfied that it is not expedient to hold such an enquiry, his/ her decision shall be final.
- 9. On the receipt of a report under Clause (5) or (6) or a determination by the relevant authority under clause (7) disclosing the occurrence of ragging incidents described in Clause 3(a), (b) and (c), the Vice-Chancellor shall direct or order rustication of a student or students for a specific number of years.
- 10. The Vice-chancellor may in other cases of ragging order or direct that any student or students be expelled or be not for a stated period, admitted to a programme of study in a college, departmental examination for one or more years or that the results of the student or students concerned in the examination or examinations in which they appeared be canceled.
- 11. In case any students who have obtained degrees or diplomas of the University of Delhi are found guilty; under this Ordinance, appropriate action will be taken under Statute 15 for withdrawal of degrees or diplomas conferred by the University.
- 12. For the purpose of this Ordinance, abetment to ragging whether by way of any act, practice or incitement of ragging will also amount to ragging.
- 13. All Institutions within the University of Delhi system shall be obligated to carry out instructions/directions issued under this Ordinance, and to give aid assistance to the Vice-Chancellor to achieve the effective implementation of the Ordinance.

## ORDINANCE XV-D: The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (Ministry of Law and Justice)

An Act to provide protection against sexual harassment of women at work place and for the prevention and redressal of complaints of sexual harassment and for matters connected there with incidental thereto.

Whereas sexual harassment results in violation of the fundamental rights of a woman to equality under articles 14 and 15 of the Constitution of India and her right to life and to live with dignity under article 21 of the Constitution and right to practice any profession or to carry on any occupation, trade or business which includes a right to a safe environment free from sexual harassment; and whereas the protection against sexual harassment and the right to work with dignity are universally recognized human rights by international conventions and instruments such as Convention on the elimination of all forms of discrimination against women, which has been ractified on the 25th June, 1993 by the Government of India.

And whereas it is expedient to make provisions for giving effect to the said convention for protection of women against sexual harassment at workplace. For details, please see the website:
