NOTIFICATION

This is with reference to the DUSU and Students Union Election 2024-25 scheduled to be held on September 27, 2024. In this context & according to the Prevention of Defacement of property Act, 2007 (Act I of 2009), it is for notification to all concerned that:-

1. Under Section 2(a) 'defacement' includes impairing or interfering with the appearance or beauty, damaging, disfiguring, spoiling or injuring in any other way whatsoever, and the word "deface" shall be construed accordingly.
2. U/Section 2(c) "property" includes any Building, hut, structure, wall, tree, fence, post, pole or Under Section any other creation.
3. Under section 2(d) "writing" including decoration, lettering, ornamentation etc. produced by stencil.
4. Sticking posters or painting slogans apart from Wall of Democracy.

Anything contrary to the provisions of the Act mentioned above is a punishable offence and the same is cognizable as contained in Section 3 of the Act with penal consequences as given below:-

- (i) Whoever defaces any property in public view by writing or marking with ink, chalk, paint or any other material except for the purposes of indicating the name or address of the owner/ occupier of such property shall be punishable with imprisonment extendable up-to 1yr. or with fine extendable up-to Rs.50,000/- or with both.
- (ii) Relevant provisions of IPC like Sections 425 and 434 and other relevant Sections of Municipal Law can also be invoked besides this section.

Accordingly, all concerned are advised not to stick posters, banners, hoardings and writings outside the limits of designated/identified places as per the SOP of DU in this regard. Failing which First information Report (FIR) will be filed against defaulters as per the Notice aforementioned.
