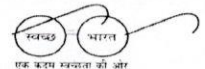

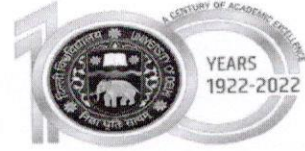

3. **11 KV RMU 2 Way** as per the standard every four months (Under Repairing)

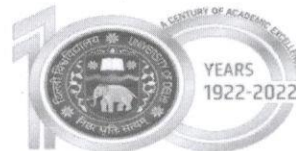

Post shutdown activities:

- Racking out of circuit breaker.
- Carry out insulation resistance test with 5kv megger during the maintenance and recording the value.
- Cleaning thoroughly all moving and fixed components.
- Lubricants of all mobile joints.
- Tightness check of all joints in Circuit Breaker.
- Check for mechanical operations.
- Check the condition of CT's & PT's cleanliness and tightness of its connections.
- Racking out of Circuit Breaker.
- Cleaning mechanism and current carrying components, insulation components with cleaning agent & dry cloth.
- Ensure that all hardware is properly secured.

Transformer

1. Observations prior to shut down:
 - Record the load currents, voltage & setting of Tap for voltage regulation.
 - Check for any unusual noise
 - Check for damages
 - Carrying out the tightness of HV & LV terminations.
 - Insulation Resistance Test.

Air Circuit Breakers

1. Observations prior to shut down:
 - Manual operation of circuit breaker.
 - Electrical operation of circuit breaker.
 - Functionality of indication lamps, push buttons, Meter & Protection Releases.

Break Down Calls/Repairs

In case of major/minor fault, the contractor shall immediately make arrangement to send qualified engineer/supervisor to the site within one hour. Every care should be taken so that the system does not lead to breakdown and case the system goes into fault, the contractor shall immediately make arrangement to send qualified engineer/supervisor to the college site within one hour and it should be rectified within the shortest stipulated time period.

Any consumables which are required to be replaced will be provided by the College. However, if the contractor is asked to provide any such consumables, he must provide rate of such items and take (prior approval of the competent authority) of the SLC authority either in writing.

All the above activities will be done in every four months.

Contractor must visit site before quoting prices and fully satisfy himself from the site conditions.





TERMS AND CONDITIONS

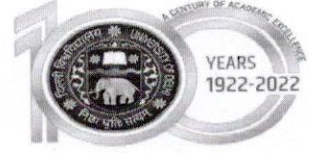
- 1) The contract is initially for a period of one year. The contract may be reviewed yearly, and may be extended for a period of maximum of three years subject to satisfactory services. However, College at its discretion can terminate the contract without citing any reason at any point of time by giving one (1) month notice. In case of termination, Institute will be liable to pay pro-rata amount to the vendor only for the period for which the AMC services availed by the Institute. On mutual consent, contract may be extended for a further period of two years on the same rates, terms and conditions.
- 2) The Non Comprehensive Annual Maintenance contract (NCAMC) is located in SLC Campus Shahdara, Delhi-110032. The selected vendor will be required to maintain the system in the mentioned site.
- 3) The contractors are advised to get acquainted with the proposed work and its site and special Conditions carefully before tendering. No claim of any sort shall be entertained on account of any site conditions and ignorance of specifications and special conditions.
- 4) Prices quoted should be for College premises and should be all inclusive of statutory taxes, fees, cases, any duties, levies, charges, surcharges and other components, etc. except GST which is to be shown separately.
- 5) The successful bidder has to submit the security deposit /performance guarantee from nationalized bank of equivalent amount of 3% of the contract value within 10 days of issue of order on awarding the contract but before execution of the agreement, to cover any loss or damage caused to or suffered by the Institute due to acts of commission and omission by the successful bidder or any failure on the part of the successful bidder in fulfillment of terms and conditions of the contract and conditions contained in the agreement. The Bank Guarantee shall have to remain valid for the entire duration of the Contract plus three months beyond the completion of contract period. The successful bidder shall not be entitled to any claim or receive any interest on the amount of performance guarantee. The EMD of the successful bidder will be refunded after submission of the performance Guarantee/Security Deposit. Successful bidder may also submit the performance guarantee in the form of demand draft payable to Principal Shyam Lal College.
- 6) The department reserves the right to close the contract at any time during the currency of the contract and 30 days' notice will be issued to the contractor without giving any compensation.

- 7) This is purely a service contract. All the staff engaged by the contractor shall solely be his liability and this department, in no way, shall be held responsible for any compensation for any of their acts/accidents.
- 8) In case of any accident during the maintenance of the equipment leading to injuries, damages to human being, equipment and or loss of life, the contractor shall be solely and fully responsible for setting all claims and indemnity. In this respect no compensation shall be made by the department. Inquiry office & shall be produced as and when required by higher officer of department.
- 9) Dismantled materials if any resulting from the replacement or repair shall be returned to the College.
- 10) If the equipment are found to be faulty and is required to be changed/repared, the matter will be reported to the concerned authority at the College
- 11) Any consumables which are required to be replaced will be provided by the College. However, if the contractor is asked to provide any such consumables, he must provide rate of such items and take prior approval of the SLC authority either in writing.
- 12) All complaints have to be attended free of cost including breakdown maintenance within a specific period/time/hours depending upon the urgency of the same. Spare parts not covered under AMC shall be provided by the College or if the contractor is asked to he must provide rate of items and take (prior approval of the competent authority) of the SLC authority either in writing.
- 13) The damaged components i.e. nut, bolt, screw etc. shall be replaced free of cost. All dismantled parts will be property of the College and shall be returned failing which recovery shall be made.
- 14) The maintenance of Transformers and HT panels to be inclusive of Lubricants, cloth, all testing equipment, tools, accessories shall be provided by the contractor. The work shall be carried out as per specification and standard of the College.





15) The contract is initially for a period of one year. The contract will be reviewed yearly, and may be extended for a period of maximum of three years. However, Institute at its discretion, can terminate the contract without citing any reason at any point of time by giving three (1) month notice. In case of termination, College will be liable to pay pro-rata amount to the vendor only for the period for which the AMC services availed by the Institute. On mutual consent, contract may be extended for a further period of two years on the same rates, terms and conditions.

Note: The bidders having valid registration with NSIC/MSME may avail exemption from submission of EMD but must enclose valid NSIC / MSME certificate/document with registration for similar works in envelope No. 1 instead of EMD demand draft. However, all bidders irrespective of their registration with NSIC/MSME have to submit the requisite Tender Fee).

Eligibility Criteria:

1. Bidder must be a proprietor/firm/company.
2. Bidder should have CPWD/PWD of any state or BSES certificate along with the valid Grade-A electrical contractor License issued by the competent Authority- voltage level 33 kv/11kv & **Bidder must be attached Certified copy of registration certificate.**
3. The bidder should have valid GST Certificate.
4. Bidder should have completed the work pertaining to Electrical works (Substation maintenance works) in CPSU/Nationalized bank/Government Department (Central/State) or autonomous bodies during the last 03 years with costing not less than Rs.15,00,000/- Bidder **must have attached their completion/experience Certificate with the technical bid.**
5. Payment will be made by half yearly Basis.
6. Solvency certificate issued by bank, must be attached with the Bid.
7. The Institute will not be responsible for any disputes that may arise between the contractor and his workers. The Centre will also not be responsible for any casualty to the workers that may happen during maintenance etc. in the Institute premises.
8. Bidder must have its registered office in Delhi/NCR within a 20 kilometer radius.

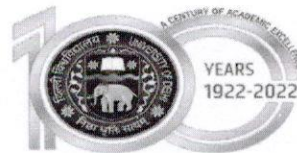

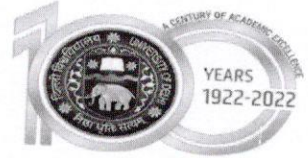

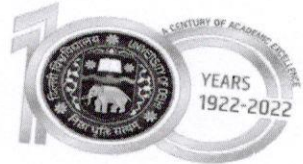
